POSITION OVERVIEW

Clinical: Behavioral health assessments- Use Short Form CANS, clinical assessment surveys, and comprehensive psychosocial assessments performed by licensed professional clinical counselors to treat, for example, depression, isolation, and anxiety. PTSD and other trauma- rooted dx. Clinical assessment & surveys will be bio- psycho-social and conducted in- person (LCSW, MFT, LPCC, PsyD, PhD)

The LPHA Clinician is responsible for the intake process and associated duties, including clinical screenings and intake procedures for new adolescent residents. This role ensures all clients receive appropriate treatment placement, risk assessments, and linkage to necessary services. This position will also provide clinical leadership through daily planned programs and activities, including psychoeducation, individual, group, and family counseling, etc.) This role works in close partnership with the program's SUD counselors, Clinical Director, Medical Director, Nurse, and Program Administrator/Facility Manager.

MINIMUM QUALIFICATIONS

- Master's degree in psychology, Social Work, Counseling or related field and holding an active license in good standing (LCSW, LMFT, LPCC, PsyD, PhD) with the proper licensing board
- Minimum of Three (3) years of experience in clinical work in an outpatient, residential, or hospital setting providing SUD or Mental Health Treatment. Experience in co-occurring mental health and SUD treatment is highly desired.
- Strong understanding of ASAM Criteria and DSM-5 SUD's; Highly knowledgeable about the biological and psychosocial aspects of substance use disorders in adolescents and their treatment, and able to identify signs and symptoms of acute conditions.
- Highly knowledgeable and experienced with co-occurring mental health disorders and treatment, intervention techniques/approaches that are developmentally appropriate for youth, with best practices such as trauma-informed care, motivational interviewing, CBT, etc.
- Experience working with and engaging with families, youth with co-occurring mental health disorders, youth in the child welfare system, youth in juvenile justice system, youth with disabilities, and/or gang affiliation.
- Bilingual in one of San Francisco's 5 Core Languages (Tagalog, Spanish, Russian, Chinese, Vietnamese), is not required, but strongly preferred

- Must pass a DOJ/FBI background check.
- If in recovery, a minimum of two years of continuous sobriety.
- Valid First Aid & CPR certification (training available upon hire by the facility).

PRIMARY DUTIES & RESPONSIBILITIES

- Conduct initial screenings, biopsychosocial assessments, ASAM level-of-care evaluations, and treatment eligibility determinations
- Develop and implement treatment plans using evidence-based approaches (e.g., Trauma-Informed Care, MI, CBT, relapse prevention).
- Provide individual, group, and family therapy; deliver psychoeducation on SUD, co-occurring disorders, and recovery.
- Complete risk assessments, crisis stabilization, and trauma-informed interventions.
- Lead family clinical conferences; coordinate care with medical providers, mental health professionals, case managers, and systems (child welfare, probation, schools).
- Support medication self-administration, tracking, and adherence to safety protocols.
- Maintain accurate and timely documentation (progress notes, treatment plans, reassessments, discharge summaries).
- Collaborate closely with the Clinical Director, Medical Director, and Administrator to ensure regulatory compliance and quality of care.
- Participate in case conferences, staff meetings, supervision, and required training/CE to maintain licensure and enhance clinical skills.
- Uphold HIPAA standards, confidentiality, and professional boundaries.
